Education and Training:

- Graduate from an accredited Pharmacy Technician Program.
- Registered with the Ontario College of Pharmacists (RPhT). (Consideration may be given to candidates who are registered with OCP (valid OCP #) and have a signed agreement documenting their intent of becoming a fully regulated RPhT within 12 months).
- Ministry of Labour "Worker Health and Safety Awareness in 4 Steps" training certificate is required.

Experience:

- A minimum of two years recent experience as a Pharmacy Technician or Pharmacy Assistant.
- Experience and demonstrated knowledge with metric conversion and pharmaceutical calculations.
- Familiarity with Pharmacy Information Systems.

Knowledge/ Skills/Ability:

- Demonstrated knowledge of extemporaneous compounding.
- Demonstrated experience in both traditional and unit dose medication distribution systems.
- Demonstrated experience in IV admixture preparation would be an asset.
- Demonstrated excellent interpersonal and communication skills.
- Ability to work independently and as part of a multi-disciplinary team.
- Strong organizational skills.

Personal Suitability:

- Demonstrated positive work record and good attendance record.
- Clear criminal record check is required.
- Able to meet the physical demands of the job (constant walking, standing, some lifting), working in a fast paced/high volume work environment.
